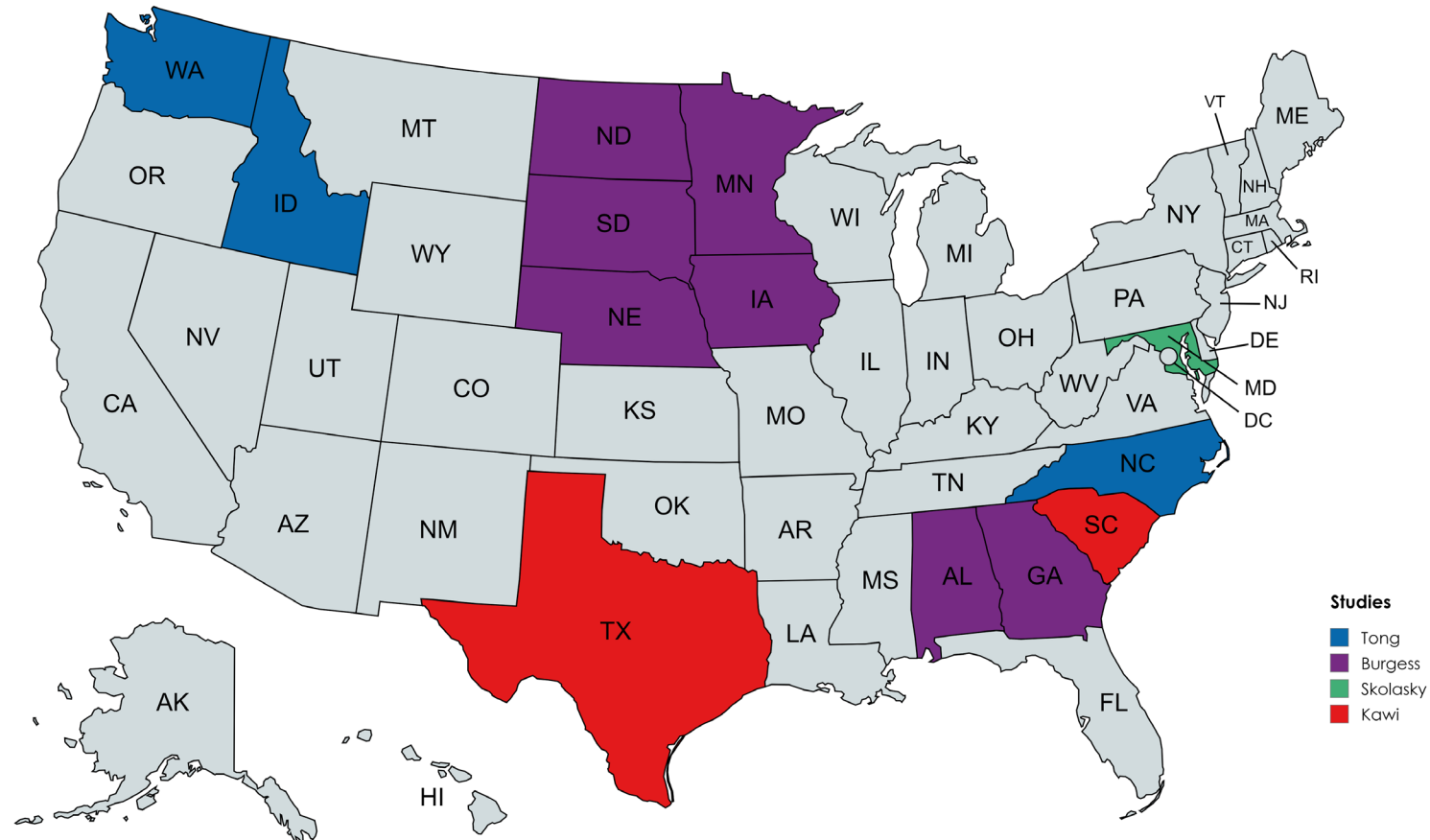

The overall goal of this initiative is to support the "real world" implementation of effective interventions to manage pain in rural and remote areas.



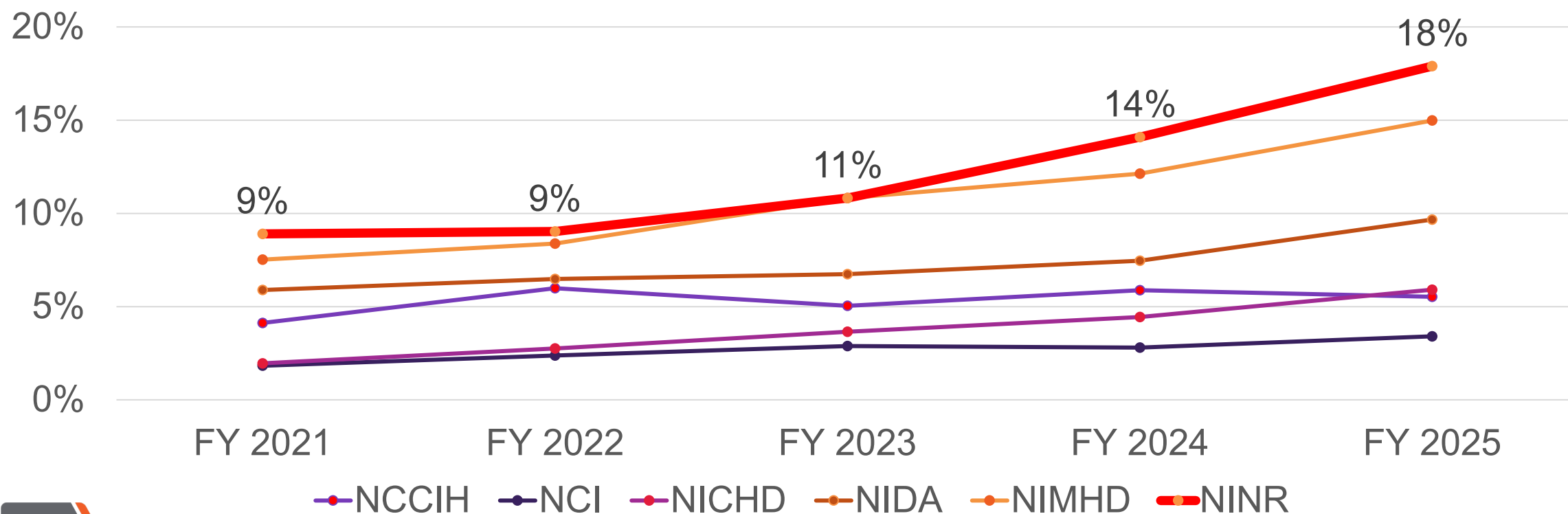

# Comparison of Proportion of D&I Awards by Institute FY2021-2025

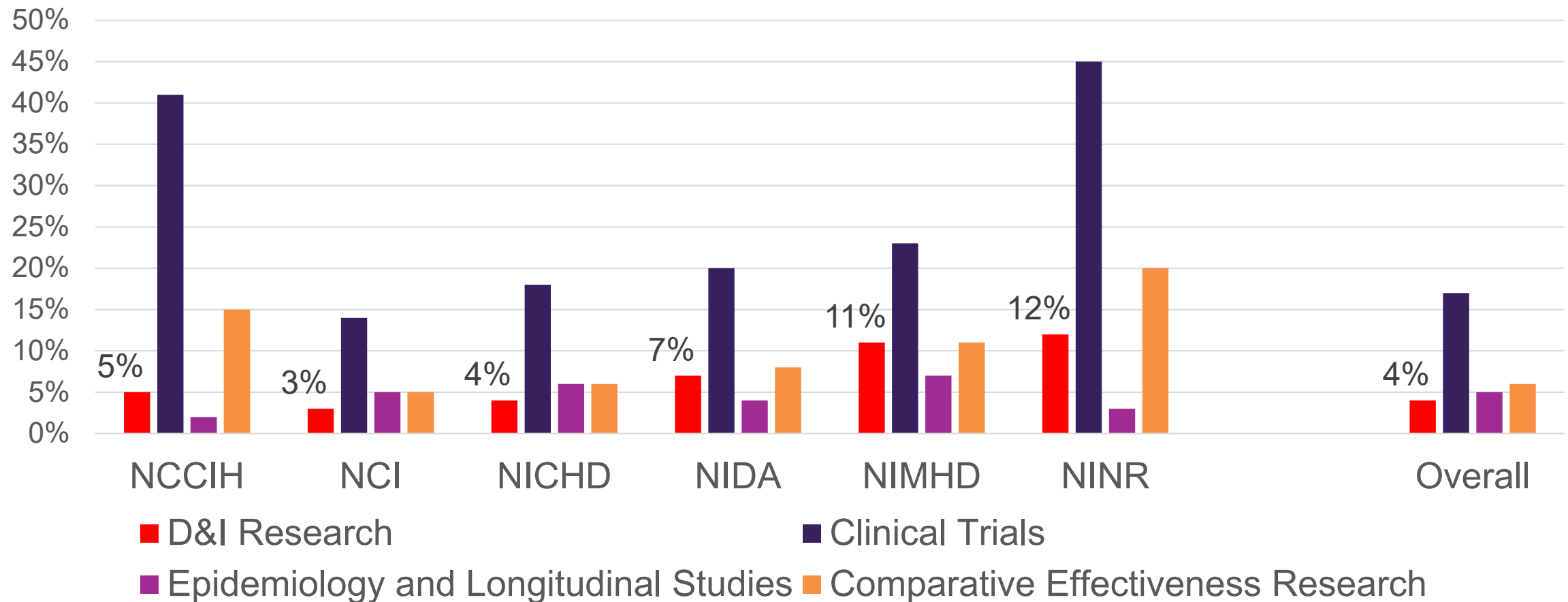

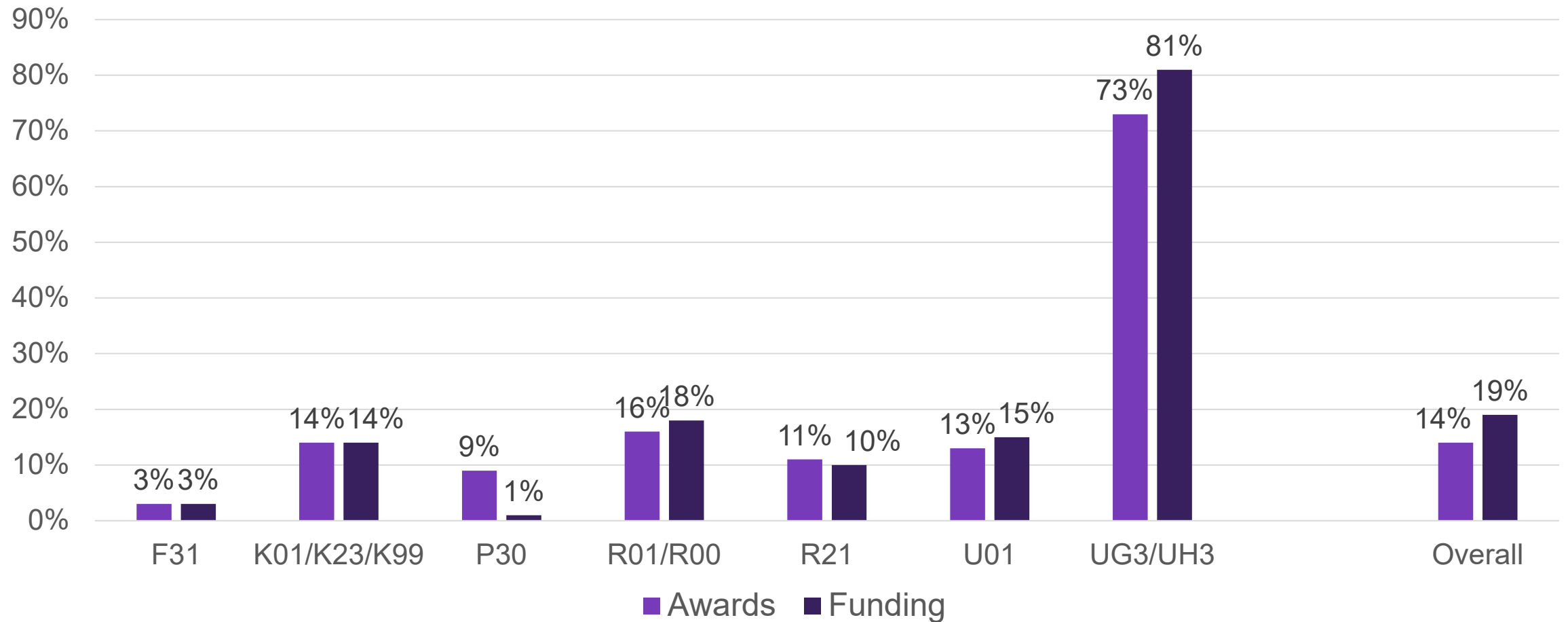
# Selected ICs' Portfolios by Type of Research FY2021-2025

(Note: not mutually exclusive)



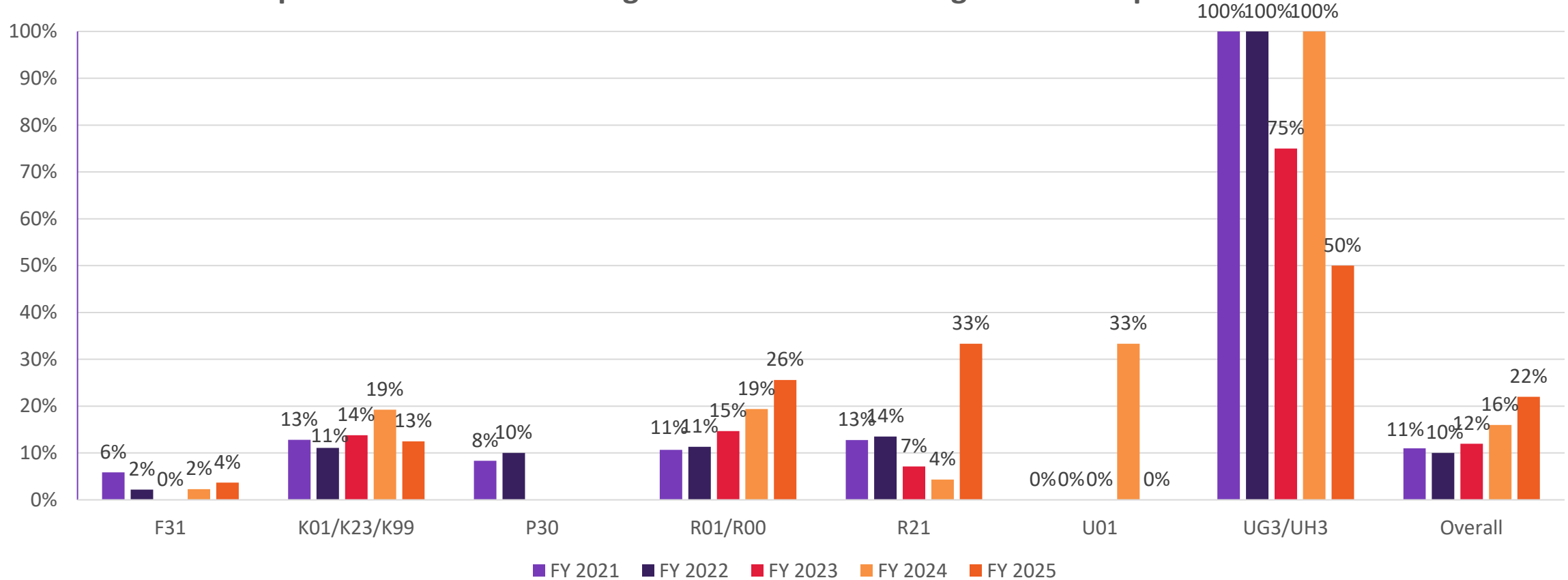


# Proportion of D&I Projects at NINR among All Awards by Mechanism FY2021-2025
