Address the holistic needs of individuals, families, and communities through effective clinical and organizational solutions that leverage nursing research to optimize care delivery



# Optimize health for all by addressing differences in distribution of health and disease

Research should seek to understand and intervene on factors that limit the optimization of health across and within populations.

- Examination of contributing factors, pathways, and mechanisms that influence health and well-being
- Intervention and implementation research using multiple study designs
- Engaging and empowering communities in the research process






Identify effective approaches to improve health and well-being by addressing the conditions in which people are born, grow, learn, play, live, and age

Research under this lens seeks to protect or improve health by addressing the conditions of daily life (e.g., education, housing, food, healthcare).

- Examination of causal pathways and mechanisms through which the conditions of daily life influence health
- Studies focusing on social risks and protective factors that are downstream effects of higher-level conditions of daily life





# Identify and address pressing health challenges within and across populations and communities

Research should seek to understand and intervene on factors that limit the optimization of health across and within populations.


- Etiologic studies identifying risk and protective factors shaping population/community health
- Applied and translational approaches, including intervention research
- Partnership with communities



## Intervene at multiple levels to prevent and manage chronic and other diseases to promote health

Research under this lens focuses on reducing the burden of chronic and other diseases and improving and maintaining health while respecting differences in human experiences...

- Research along the continuum from primordial prevention to tertiary prevention
- Efforts facilitating behaviors that reduce risk, improve health, manage disease, and enhance well-being
- Investigating interventions, and strategies, and under what conditions they work





Address the holistic needs of individuals, families, and communities through effective clinical and organizational solutions that leverage nursing research to optimize care delivery

Studies examine how healthcare and health services are delivered to improve care across conditions, events, and contexts

- Designing new models or evaluating existing models of care
- Care coordination and continuity of services
- Interrogation of obstacles to care
- Approaches that are person-centered and holistic




## Key Takeaways



On March 15, 2025, the President signed H.R. 1968, the FY 2025 full-year continuing resolution (CR). This bill provides funding of \$48.5 billion in FY 2025 for NIH.

# NIH-wide NOFO Reduction Initiative and Consolidation of Review

- NIH has move towards consolidated review; All first level of review now conducted at CSR rather than in individual ICs;
  - NIH has expired several IC specific NOFOs;
  - Increase efficiency
  - Reduce bias
  - Improve quality and consistency
  - Reduce confusion and reviewer burden.



## **New Resource: Highlighted Topics**

NIH Funding - Find a fit for your research highlighted topics

## Highlighted Topics Resource

- Informs the research community about NIH areas of scientific interest.
- Encourages investigator-initiated applications in those topic areas.
- May include new or emerging areas.
- Will expire after 1 year. NIH may extend.
- Help reduce NIH's use of funding opportunities by highlighting a topic instead (as appropriate).

## Benefits for Research Community

- Reduce the effort to search and apply for funding opportunities.
- Apply through one of the <u>NIH Parent</u> <u>Announcements</u> or other broad NIH opportunities at Grants.gov.
- Search topics by keyword and filter by participating NIH Institutes, Centers, or Offices.
- Check back often for new topics and webpage features.

# **Supporting Fairness and Originality in NIH Research Applications (NOT-OD-25-132)**

- NIH will not consider applications that are either substantially developed by AI, or contain sections substantially developed by AI, to be original ideas of applicants.
- NIH will **only accept six** new, renewal, resubmission, or revision applications **from an individual PI or MPI** for all Council rounds in **a calendar year**.
